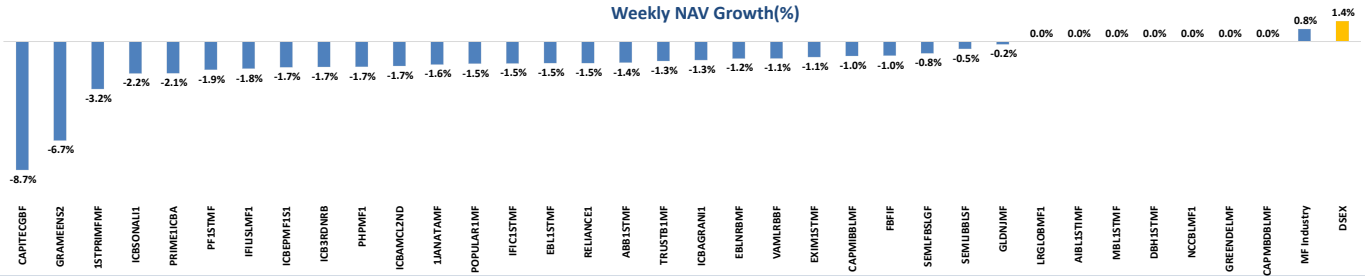

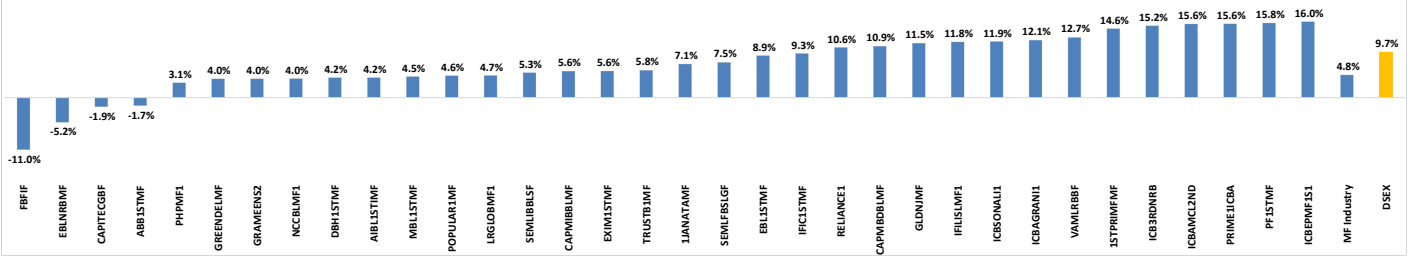

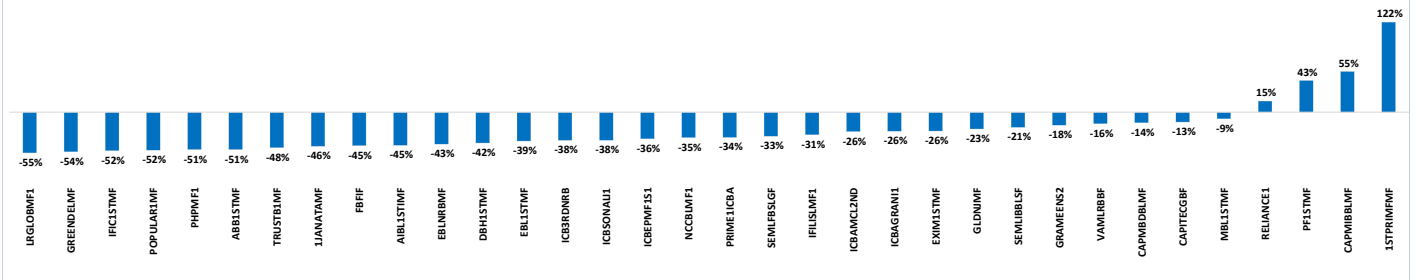
Weekly NAV Growth(%)



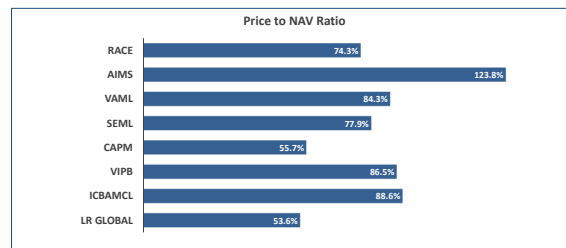
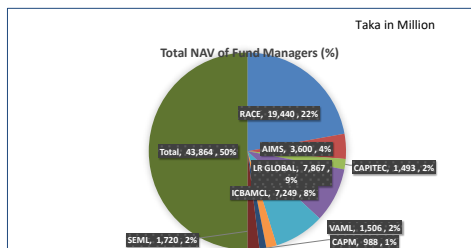
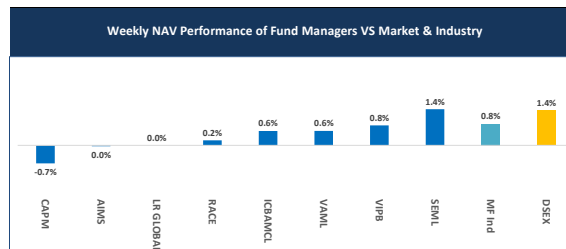
YTD (%) Change
